

Water withdrawal notification

Tchesinkut Lake East – POD 18 – Registry #2311

Coastal GasLink is committed to creating an extraordinary legacy of safety and respect for all people, communities and the environment. As part of this commitment we are keeping our neighbours along the project route informed on construction activities happening near their community. Please note the following information:

What: Water withdrawal activities for hydrotest, drilling water, roadway construction, upgrades and maintenance, right-of-way construction and reclamation activities.

When: The hose is expected to be installed on February 1, 2021.

Where: The hose will be installed at Tchesinkut Lake at 54° 4' 9.00" N, 125° 29' 8.72" W along Construction Section 6. The nearby communities of Burns Lake, Tchesinkut Lake, Endako, Fraser Lake, François Lake, Sheraton, Grassy Plains and Takysie Lake will be notified.

Expected Duration: The hose is expected to be removed on April 30, 2021.

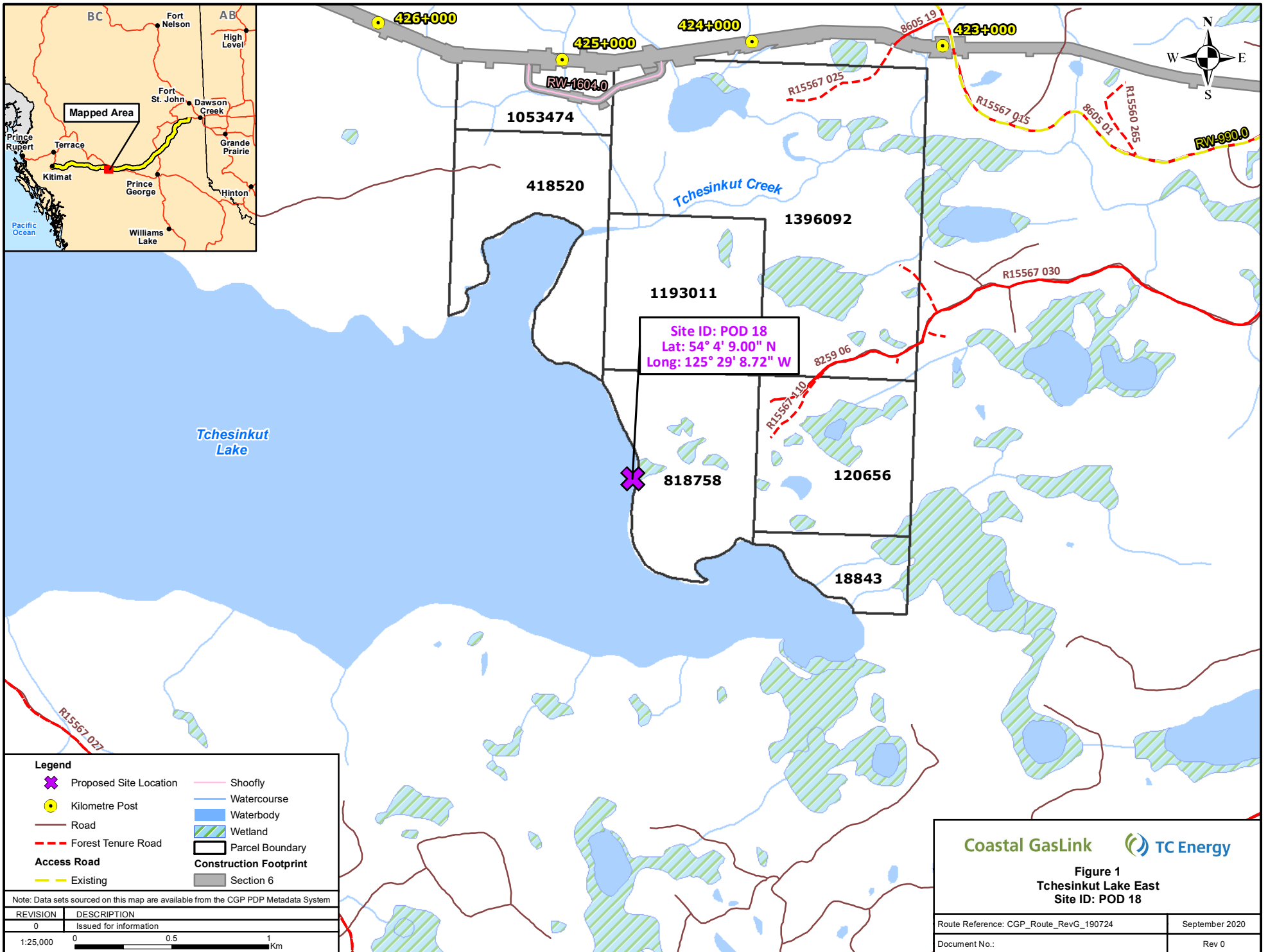
