

# Water withdrawal notification

## Ormond Creek – POD 24 – Registry #4029

*Coastal GasLink is committed to creating an extraordinary legacy of safety and respect for all people, communities and the environment. As part of this commitment we are keeping our neighbours along the project route informed on construction activities happening near their community. Please note the following information:*

**What:** Water withdrawal activities to support general construction activities. The hose will be submerged as required and will not remain on site for the duration of the water withdrawal period.

**When:** Water withdrawal is expected to begin on September 27, 2021.

**Where:** The hose will be installed at Ormond Creek at 54° 7' 3.59" N, 124° 46' 15.50" W along Construction Section 5. The nearby communities of Fort Saint James, Dog Creek, Tintagel, Sheraton, Savory, Endako, Stellako, Lejac, Fort Fraser, Braeside, Prairiedale, Engen, Willowvale, Glenannan, Nithi River, and Nulki will be notified.

**Expected Duration:** Water withdrawal is expected to conclude on September 26, 2023.

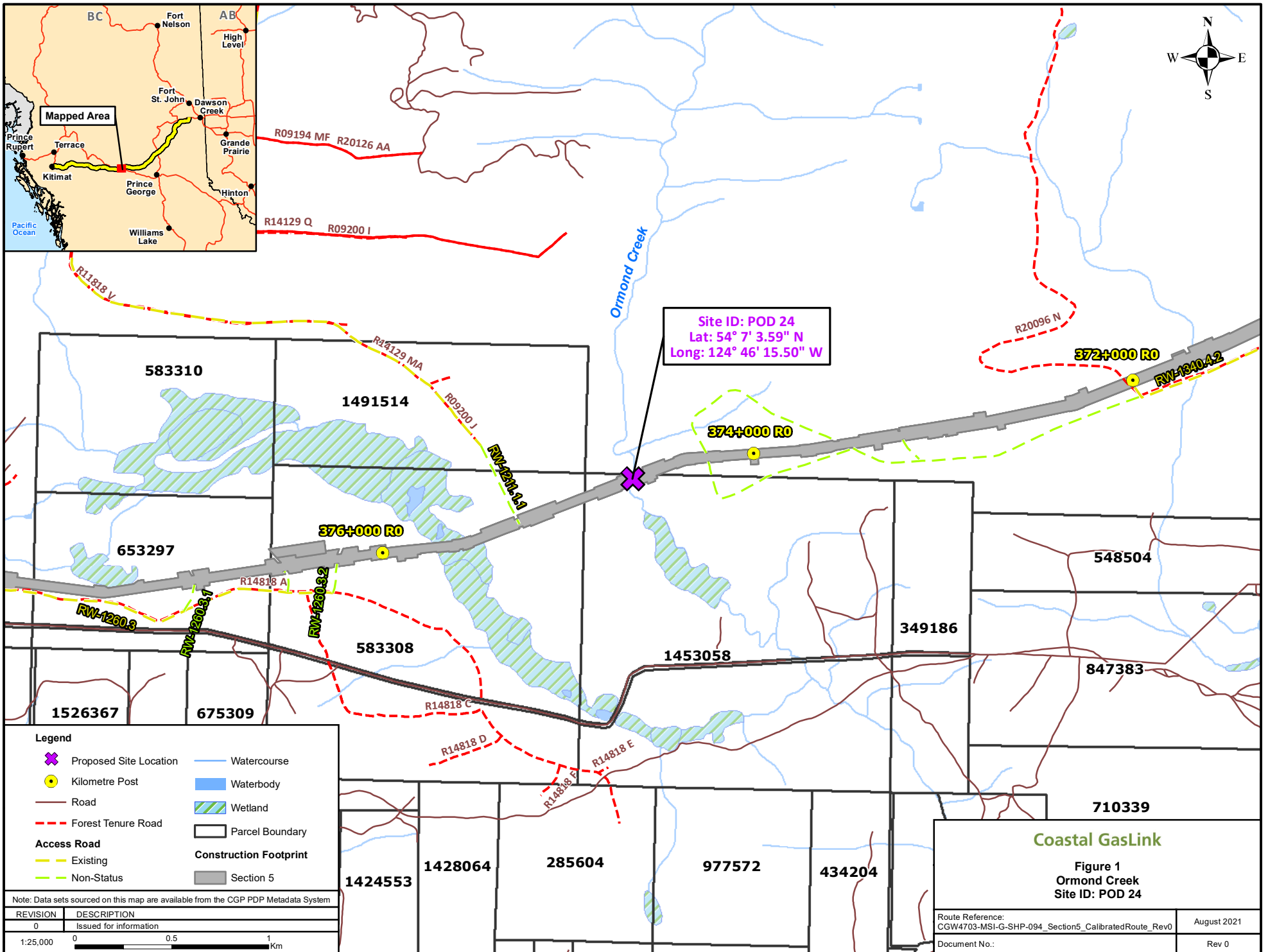
