Construction highlights

Project Update: Summer construction planning underway

Coastal GasLink continued to safely progress essential activities in April to pave the way for a careful ramp-up of work over the coming weeks and months, in accordance with recently issued government guidelines.

Clearing continues to safely advance along the route, with important progress made in Sections 1 and 6. Pipe deliveries by rail and truck have also continued, with 297 kilometres of pipe delivered to date.

A key focus for the near-term is managing erosion and sediment control to protect local waterways from potential run-off, and planning for additional site preparation activities.

Over the coming weeks, work will continue on the Vanderhoof, Huckleberry, and P2 Lodges, and to reconfigure 9A Lodge, in partnership with Indigenous communities.

Each worksite and workforce accommodation is unique, and we are working closely with Northern Health and our

contractors to enhance our already robust health and safety program, and implement site-specific plans in accordance with government guidelines. Our medical service provider, International SOS, is also helping to ensure our workers are healthy and fit for work through enhanced health screening measures.

As spring thaw comes to and end, we are preparing for a slow and steady increase in activities leading up to our summer construction program. Towards the end of May, we anticipate workforce numbers to gradually increase to approximately 650 workers – including those from local areas – with work focused on environmental monitoring and field work, grading, grubbing and site preparation to position the project for pipe assembly and installation later in the summer.

The health and safety of our workforce, their families, and surrounding communities is at the forefront of everything we do. That's why work will only ramp up when all measures are implemented with the required approvals from local and provincial health authorities.



- Completed Wilde Lake Compressor Station clearing

- Continue pipe hauling and delivery to Section 1 storage sites until end of May 2020
- Ongoing environment and erosion control monitoring and management
- Resume access road and Chetwynd accommodation development in June 2020
- Preparing construction readiness for summer mainline pipe installation





Pipelines are built to consider both human-caused and natural events such as wildfires and earthquakes. 



Construction progress:

- Completed communication and ongoing accommodation set up at Hunter Creek Lodge
- Commenced helicopter assisted hand-felling trees in the mountainous Icy Pass area
- Clearing of access to Cable Crane hill ongoing
- Completed fencing at Houston storage site
- Access to the North Kitimat crossing ongoing to install pipe under the river

Upcoming activities*:

- Continue clearing on priority work fronts
- Blasting activities continuing as required by right-of-way conditions
- General maintenance on North Kitimat, North Hirsch and South Hirsch roads
- Installation of pipe under the North Kitimat crossing
- Re-establishment activities for 9A Lodge
- Pipe deliveries continue in the Kitimat area until April 2021
